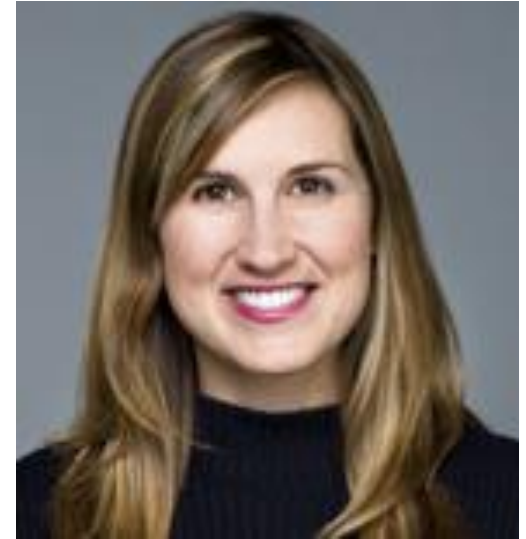

FY23 SCHOOL BUDGET HIGHLIGHTS

The FY23 initial budgets for each DCPS school continues the historic investment Mayor Bowser is making in education.

- No school receives less than their FY22 submitted budget.
- A new Recovery Fund provides stability and additional funding to ensure schools can maximize their buying power for FY23.
- Schools will receive funding aligned to their student enrollment and level of need and will also receive additional funds to support students with greater needs.

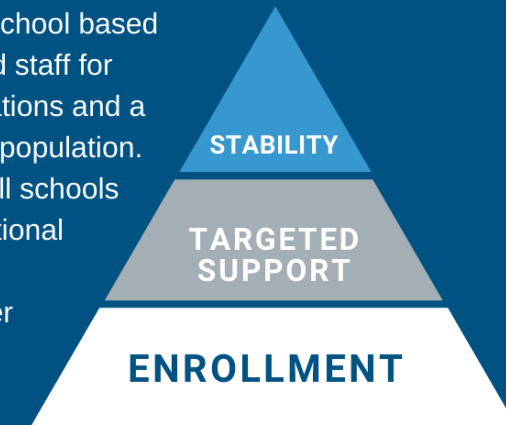

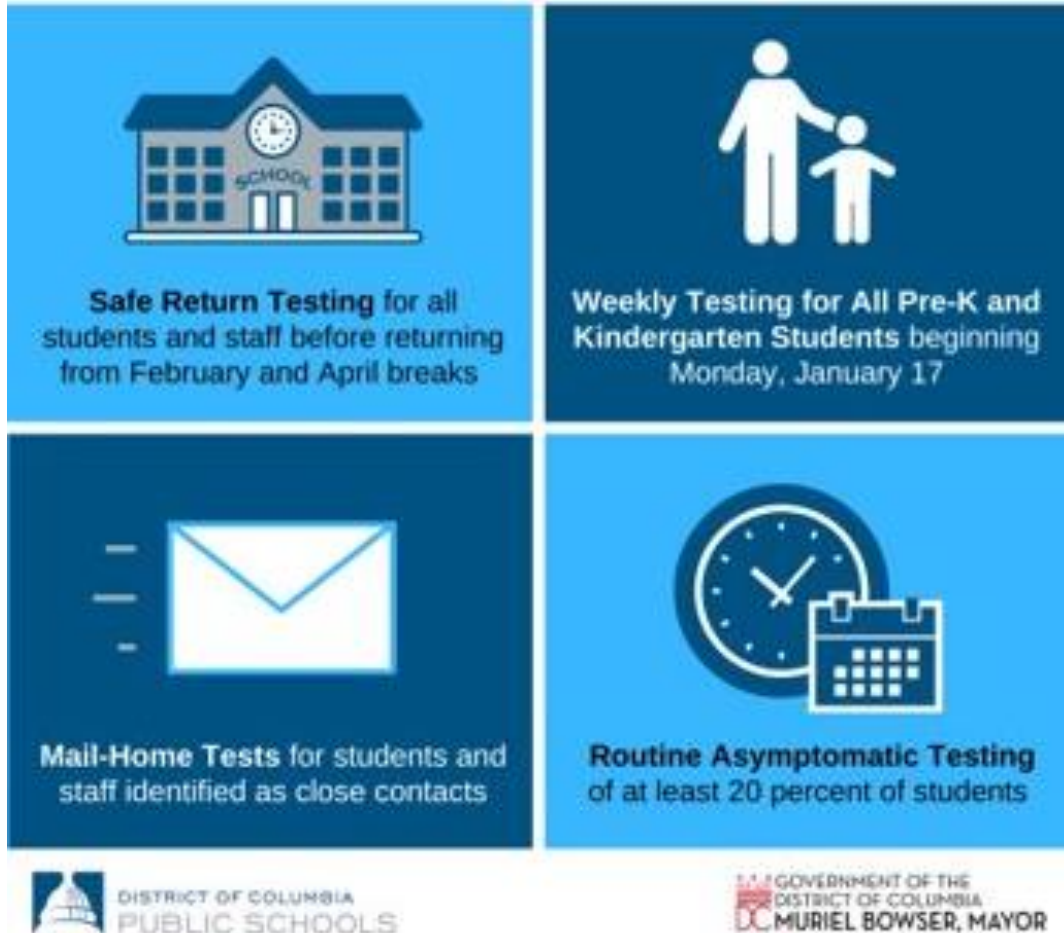
FY23 SCHOOL BUDGET FUNDING CATEGORIES

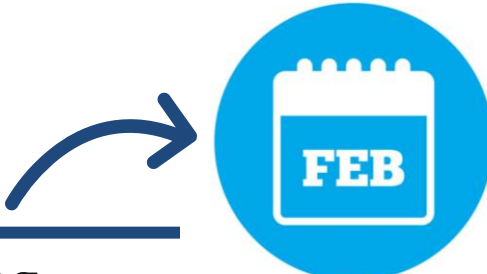
The updated DCPS school budget model is based on student enrollment, targeted need, and year-over-year stability.

Funds are distributed to a school based on its students and required staff for both special student populations and a school's general education population. Stability funds will ensure all schools can afford important educational services for their students, especially through year-over enrollment transitions.

Safe Return Testing- Proof of a Negative Test is Required: February Break Update



Safe Return Testing for all students and staff before returning from February and April breaks

Maintaining the health, safety, and well-being of our staff, students, and families is our top priority. In collaboration with our health partners, it was determined that requiring 100% of students and staff to test prior to returning to school was a critical strategy to reducing the spread of COVID in our schools.

Test to Return Process Overview

**1**

Pick up a COVID-19 rapid antigen test at your school.

Tests will be distributed on Friday, February 18.

You can also pick up a rapid test at other public sites around the city.

Updated 2/14/22**2**

Take the at-home test on Sunday, February 27

Follow the instructions provided in your kit.

Updated 2/14/22**3**

Upload proof of your negative test results to dcps.dc.gov/safereturn by Sunday, February 27 at 9:00 pm.

Set a reminder on your calendar to complete this step!

Updated 2/14/22**4**

Continue to monitor for any symptoms of COVID-19.

Get vaccinated.

Receive your booster.

Wear a mask.

Stay home if you are feeling sick.

Reporting Your Child's Test Results

What if my child tests positive?

- ✓ Please upload your positive results in the database and begin isolating immediately.
- ✓ All individuals regardless of vaccination status or recent COVID infections must isolate, if they test positive.
- ✓ There is no option to reverse a positive test result with additional testing.



When can my child return to school, if they test positive for COVID?

- ✓ Your isolation period may be different based on the severity of your COVID infection and whether you participate in additional testing.
- ✓ Individuals with severe or critical COVID illness or are immunocompromised **must isolate at least 10 days from when symptoms first started**. Please follow the advice of your health care provider.

If you receive a positive test on day 5 or later OR if no antigen test is taken on day 5 or later, you **MUST** isolate at least 10 days from when symptoms first started or initial positive test.

If you were initially asymptomatic and start to have symptoms, your isolation period starts over from the date of onset of symptoms.

We are expanding Pre-K Test to Stay for all positive cases in Pre-K classes.

- ✓ Over the last few weeks, we have been utilizing a [test-to-stay protocol](#) for a limited number of positive cases in classrooms with our youngest learners who are not yet eligible for the life-saving vaccine.
- ✓ **Effective February 10, if any positive COVID-19 case is reported in a Pre-K classroom, all students in that classroom will participate in the test-to-stay pilot.**
- ✓ The test-to-stay pilot program is designed to keep our youngest learners safely in the classroom with rigorous testing while limiting the disruption that classroom closures have on families. However, there may be times when operational impacts may still require a class to transition to virtual learning for a period.
- ✓ As a reminder, all students who are fully vaccinated and have no symptoms may continue to attend school in-person if they are identified as a close contact, unless a class must move to virtual learning due to operational impacts. We encourage all eligible students to get vaccinated to avoid serious illness and be able to continue attending school in-person.

Pre-K Test-to-Stay Pilot Expands

SUNDAY

All prekindergarten students are required to test at home.



MONDAY

A new positive case is reported at school.



TUESDAY

Students in the impacted classroom are tested at school.



WEDNESDAY

THURSDAY

If a student tests positive in Tuesday's follow-up testing, the class will be tested again on Thursday.



FRIDAY

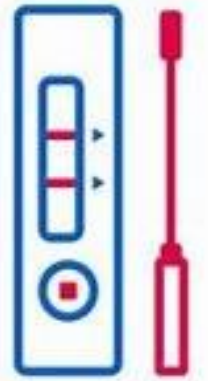
All prekindergarten students are sent home with test kits to take on Sunday.



Test Kits & Mask Distribution Update

Over 300K test kits have been delivered to schools to support ECE weekly testing, test-to-stay operations, and test-to-return operations at all schools after the February Winter Break and April Spring Break.

- ✓ **Test-to-Stay for schools with PK3 and PK4 Students:** Schools received 20 kits per enrolled PK3 and PK4 student. This supply will ensure each student receives 3 tests weekly in line with current test to stay guidance.
- ✓ **Test-to-Return for all Schools:** Schools received 2 kits per enrolled students in grades K-12 and **all staff, partners, and contractors**. This will ensure that staff and students take a test prior to return the day after the week-long break.
 - For the February and April test-to-return operations, schools will be expected to distribute test kits to students during the days before the break begins. Unlike the holiday test-to-return operations, schools will not distribute test kits to any DCPS student or family member – only to enrolled students.
- ✓ **KN 95 Masks:** DCPS distributed sufficient KN95 masks to schools to support weekly distribution to teachers through April 18, 2022.

Key Updates include:

1.

PCR **AND** rapid antigen tests can now be used for close contacts to return from quarantine. Staff and students who are close contacts of someone with confirmed COVID-19, **regardless of their vaccination status** should get a COVID test 5 days after the date they were exposed. **(As a reminder, any individual that is identified as a close contacts can have two PCR test mailed to their home.)**

2.

Persons, who have had COVID in the last 90 days and are asymptomatic, do not have to quarantine if identified a close contact.

3.

A person who tests positive for COVID can end isolation after 7 days (previously 10 days) and return, if fever/symptom free for at least 24 hours without the aid of medication AND has taken and received a negative antigen test, unless the person had severe COVID and/or is immuno-compromised.

Test To Stay programs can be used as a strategy to keep individuals that normally would be required to quarantine, safely in schools.

5.

There is absolutely no option to reverse a positive test result with additional testing. Anyone with a positive test result must not attend school and must begin isolation.

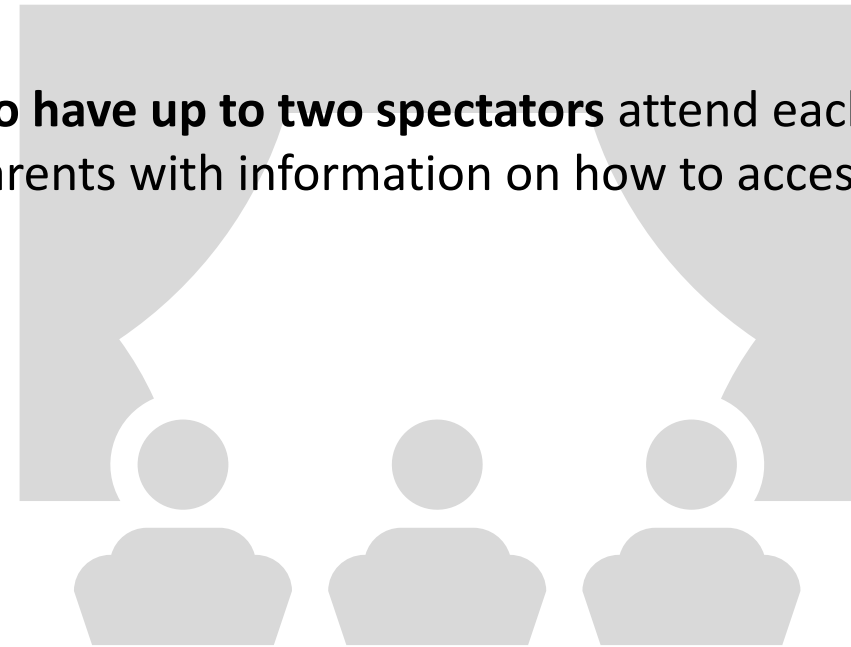

Adults and students (18+) who are eligible must have received the booster to be considered “up-to-date”. **Adults and students who are not fully vaccinated (up-to date) would have to quarantine, if identified as a close contact.**

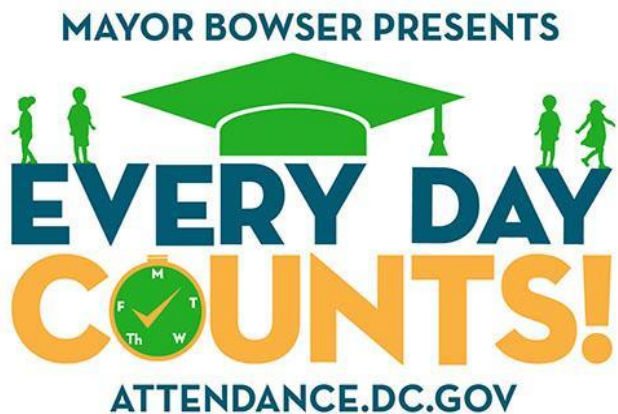
Audience and Spectator Guidance

For any DCPS athletic event, arts performance or student showcase, it is important to balance maintaining social distancing guidelines and wanting our students to enjoy the support of having their families and community in attendance at special moments.

- ✓ At this time, **each student participant will be able to have up to two spectators** attend each event.
- ✓ Athletic directors or event organizers will provide parents with information on how to access tickets or attendance lists as needed.



Attendance Reporting During a Quarantine

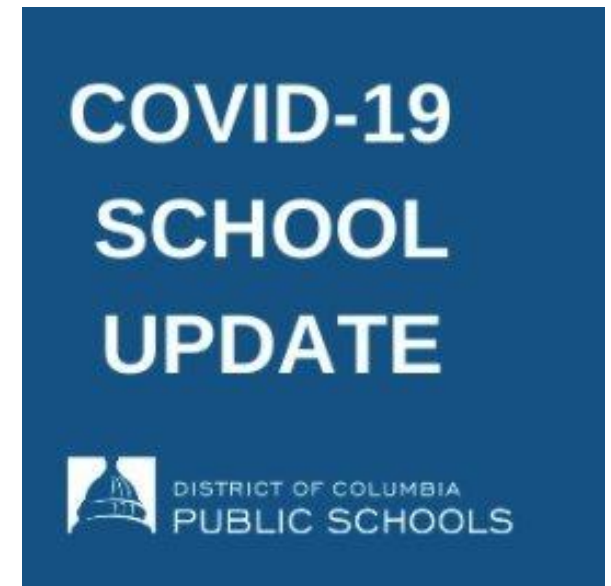


- ✓ For students who are required to quarantine but not at the direction of DCPS (e.g., because a family member tested positive for COVID-19 and they were contacted by a contact tracer), the parent/guardian must provide written documentation of the quarantine.
- ✓ The written note must include the date of COVID-19 exposure; the length of time the student has been directed to quarantine by a medical professional or contact tracer; and the name, organization, and contact information of the medical professional or contract tracer.

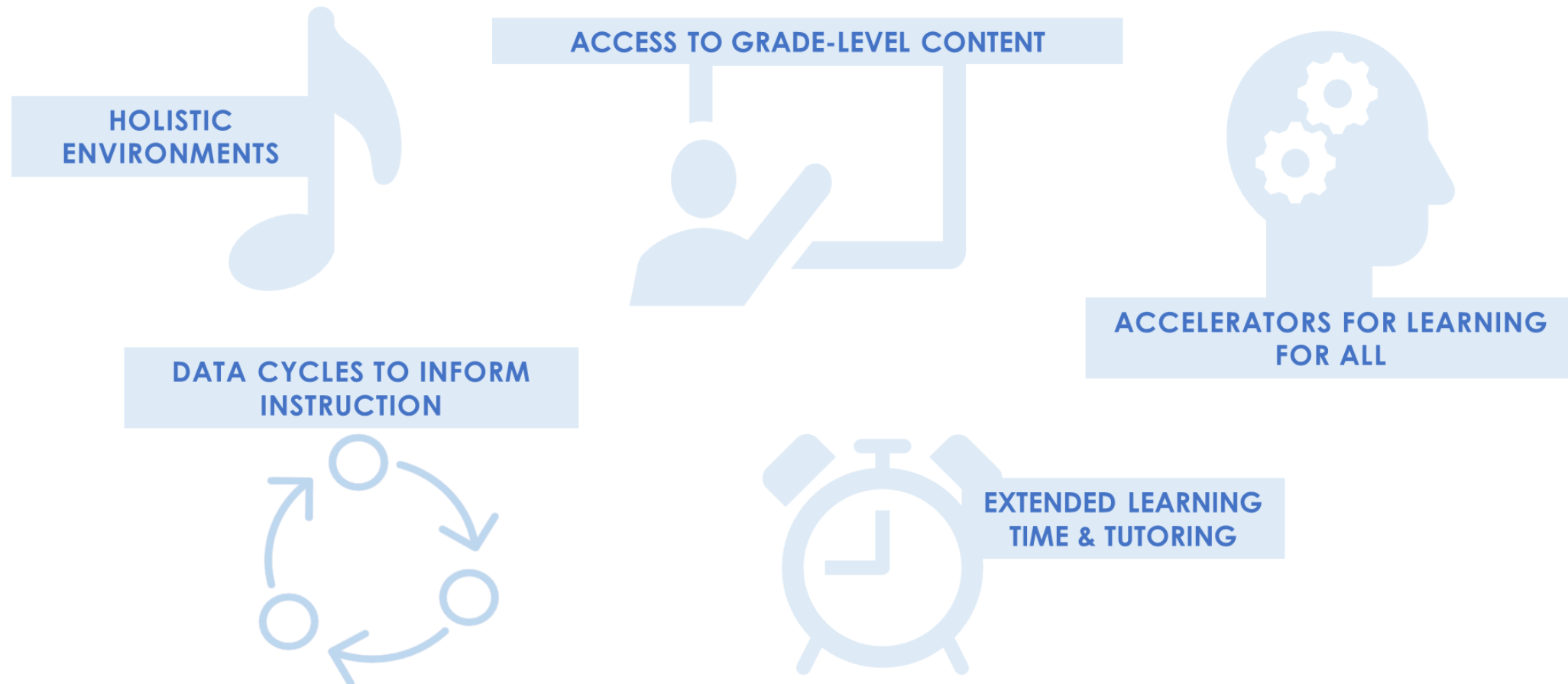
Please note, students required to quarantine at the direction of DCPS do not need to provide documentation. **Beginning January 18,** Pre-K students who have not completed testing will not be permitted entry and their absence will be excused for up to 10 calendar days, but if a student is absent for five (5) or more consecutive days, further official documentation is required, besides a parent note.

Staying Informed on COVID-19 Cases

- ✓ Community notices sent to school communities will include a total number of COVID-19 cases reported to the school each day.
- ✓ You can view each day's totals at dcpsreopenstrong.com/updates.
- ✓ This information is based on cases initially reported to schools prior to 11:00 a.m. that day.
- ✓ Community notices will be sent Sunday through Friday, except for school holidays.
- ✓ Final verified case counts will continue to be available at coronavirus.dc.gov/page/dc-schools-data.



Our Focus on Academics and Acceleration



Our Focus on Academics and Acceleration

Tier 1

Understanding and meeting the needs of all students and adults within a **grade/content level**

Example: Strategically reviewing 2nd grade vocabulary of halves and fourths at the beginning of a 3rd grade unit about fractions.

Tier 2

Deeper understanding of a **subset** of students, designing aligned supports, and reflecting on impact

Example: Providing some students with an additional small group to practice newly introduced skills during the math block.

Tier 3

Deeper understanding of **individual** students, designing aligned supports, and reflecting on impact

Example: Providing 1:1 tutoring to students to support them in grade-level math content.
